## UPDATE ON DEVELOPMENT PROPOSALS AND PROJECTS

BRADFORD PLACE - BEHLMANN BUILDERS, INC. Twenty-three acres on the east corner of Vaile Avenue and Old Halls Ferry Rd.

STATUS - Councilman Bond recommended to the County Council that 1,500 sq.ft. be the minimum house size. The number of homes proposed has been been reduced to 52. County Council has approved this development.

AFSHARI ENTERPRISES, INC. Five acre tract on the north side of Lindbergh, 1/4 mile west of Highway 367.

STATUS - Planning Commission voted on May 1st to deny this proposal by a vote of 8-0. It was recommended that a study be made of the problem of stormwater runoff in that area. A modified site plan was sent to the County Council from attorney John King on June 13th. This plan was sent to the Planning Commission for review.

The new plan shows that a total of 4,000 sq. ft. has been eliminated from the two buildings, retail was totally removed, and parking was reduced. There was no reference made of a study or of any dramatic change in the control of the stormwater.

A letter from the Planning Commission reiterating the reasons for the May 1st denial was received by the County Council on July 13th. Councilman Don Bond will be reviewing all the information on this proposal. No date has been set on when it will be presented to the Council.

PARC ARGONNE ESTATES - M.J. BEHLMANN Old Jamestown Rd. and Vaile Ave. 49 acres with 37 one acre (R-1) lots.

STATUS - Nine lots sold. 5 houses built, 3 houses under construction and one display home.

GLEN EAGLES - GARY MAZANDER
Southeast side of Vaile Ave. northeast of Old Halls
Ferry. 66 acres with 21 three acre (Non-Urban) lots.

STATUS - Streets and utilities installed. 5 lots sold. One house under construction.
