
Building plans for the proposed Walmart



Northwest Parkway is a transportation project that will look at creating an improved, more reliable connection between the residential areas of North St. Louis County and employment centers in the Earth City and Riverport areas. The existing link, consisting largely of twolane roads in the Missouri River floodplain, is subject to unpredictable floodrelated road closures. The closures cause unreliable travel conditions and traffic disruptions.

The current project will identify a transportation alternative that will:

- Eliminate flood-related detours between Charbonier Road and Earth City Expressway;
- Address capacity needs in northwestern St. Louis County;
- Enhance safety along St. Louis County roadways in the study area; and
- Provide access to the economic opportunities within St. Louis County.



RALPH WEHMER'S STORIES

"I have so many stories to tell you. Where do I begin? Well, I was born in a log cabin [January 1916], one mile down from this house [Old Jamestown and Carrico]. Back then, our street was called Accommodation Road, and it was a dirt road. Now, the street is called Old Jamestown Road.

"Growing up, my brothers and I would ride a corn grinder and it would go round and round like a merry-goround. One afternoon, my brother and I were riding on it and Ed came out of the house and yelled at us: 'Do not put your hands in there!' Next thing I knew, I put my hand in the grinder and I lost part of my finger. Boy, did I cry -- for hours. Because the nearest doctor was in Florissant, we drove our Model-T car. Because the road was dirt, we hitched it to a team of mules and we headed down the street to Salem Baptist Church with the reins through the windshield opening. We left the mules at the

church and drove on into Florissant to the doctor's office. Every time we went to the doctor's, this is how we traveled...."
